RESOLUTION # 16-05-02

A RESOLUTION AUTHORIZING COUNTY BOARD CHAIRMAN TO WITHDRAW FROM THE AGING AND DISABILITY RESOURCE CENTER OF BUFFALO, CLARK AND PEPIN COUNTIES

WHEREAS, in 2009, the Buffalo County Board entered into an Intergovernmental Agreement forming the ADRC of Buffalo, Clark and Pepin Counties; and

WHEREAS, in 2012, an updated Intergovernmental Agreement went into effect to continuing operation of the ADRC of Buffalo, Clark and Pepin Counties; and

WHEREAS, the Director of the Wisconsin Department of Health Services' Bureau of Aging and Disability Resources has set a goal to integrate aging services and ADRCs across the State of Wisconsin; and

WHEREAS, the Greater Wisconsin Agency on Aging Resources, Inc. (GWAAR) has expressed support of an integrated model; and

WHEREAS, in 2015, the ADRC Board of Buffalo, Clark and Pepin Counties created a Task Force, including Chippewa County, to explore organizational designs that integrate aging services and ADRCs; and

WHEREAS, ADRCs serve adult developmentally and physically disabled and aging populations; and

WHEREAS, in March, a full integration organizational design was presented to the Task Force and ADRC Board which would integrate aging, transportation, adult protection and other adult services into the ADRC; and


WHEREAS; Buffalo County is seeking to meet the express State goal of service integration for the ADRC target populations and seeks county partners to jointly pursue this goal via a regional approach; and

WHEREAS, Buffalo, Chippewa and Pepin County Task Force and ADRC Board members have expressed support for this full integration model ; and


WHEREAS, Clark County Task Force and ADRC Board members have expressed opposition to this full integration model; and

NOW, THEREFORE BE IT RESOLVED, that the Buffalo County Board of Supervisors hereby grants authorization to the County Board Chairman to serve notice to Clark and Pepin Counties of withdrawal from the ADRC Intergovernmental Agreement effective 1/1/17.
