## A RESOLUTION TO PURCHASE DISPATCH TELEPHONE WIRELESS HEADSETS

**WHEREAS**, the Buffalo County Sheriff's Office currently operates using landline telephones within the Dispatch Center, and

**WHEREAS**, the landline telephones are used to answer all emergency/non-emergency incoming calls, as well as outgoing calls, and

**WHEREAS**, it is imperative that the Dispatch Center continue to strive in ways to promote ways to maintain a safe community; including officer well-being and safety, and efficiency in their duties, and

**WHEREAS**, the Dispatch Center has borrowed and put to use a wireless headset for, on or about, two months, and

**WHEREAS**, the Buffalo County Sheriff's Office is asking for fourteen (14) wireless headsets in order to accommodate Communication/Corrections staff, and

**WHEREAS**, Due to the importance of the well-being of the Communication/Corrections staff, as well as the functionality and efficiency of the Dispatch Center, this purchase should be taken from said fund, and


**WHEREAS**, the Buffalo County Sheriff's Office has retained three (3) quotes for (14) individual headsets, together with minimal, but necessary hardware. **1) ANCOM Communications** \$5,960.00 **2) Libertel Associates** \$2,551.35 **3) Talk Point** \$3,066.00.

**NOW, THEREFORE BE IT RESOLVED**, that the Buffalo County Board of Supervisors, upon law enforcement recommendation, hereby grant authorization to purchase fourteen (14) new wireless headsets, together with minimal, but necessary hardware, in the amount of \$2,551.35 to vendor, Libertel Associates. Said purchase amount should be taken from the available funds in the Buffalo County Law Enforcement Budget.

Adopted at a duly called and noticed meeting of the Buffalo County Board of Supervisors on the 27<sup>th</sup> day of June, 2016.






