

**DISASTER PROCLAMATION  
BUFFALO COUNTY, WISCONSIN**

WHEREAS, on August 11, 2016 a disaster, namely **HEAVY RAIN AND FLASH FLOODING** has struck Buffalo County [Subsequent Rain and Flooding 8.19-8.20]

WHEREAS, because of such emergency conditions, the Buffalo County Board of Supervisors was unable to meet with promptness a disaster was declared pursuant to the Buffalo County Emergency Operations Plan:

WHEREAS, pursuant to sections 323.11 and 323.14(4)(b) of the Wisconsin Statutes it is necessary and expedient for the health, safety, welfare and good order of Buffalo County, that there is a need to proclaim that emergency conditions exist;


NOW THEREFORE, as Chief Elected Official of the County of Buffalo, I do hereby **proclaim a state of emergency in effect until further notice.**
