A RESOLUTION AND BUDGET MODIFICATION TO CREATE A FULL-TIME ECONOMIC SUPPORT SPECIALIST POSITION

WHEREAS, Buffalo County Department of Health and Human Services (DHHS) is one of the eight county members of the State mandated economic support consortium called Western Region Economic Assistance Consortium (WREA); and

WHEREAS, WREA has authorized and requested Buffalo County DHHS to eliminate a La Crosse position and create and fill an Economic Support Specialist position to be located in Buffalo County for the consortium; and


WHEREAS, the Economic Support Specialist determines eligibility for Medical Assistance, Badger Care, Food Share and other economic support services; and

WHEREAS, each WREA consortium allocated State funds are pooled into one budget for WREA which includes a fixed amount of tax levy which each county pays to WREA based on maintenance of effort data and not on the number of positions that the county employs; and


WHEREAS, adding an Economic Support Specialist position will not add any additional tax levy costs to Buffalo County and Buffalo County will receive reimbursement for all position expenses of salary and benefits.

NOW, THEREFORE BE IT RESOLVED, that the Buffalo County Board of Supervisors hereby grant authorization to establish and fill an Economic Support Specialist position.
