A RESOLUTION TO CREATE A FULL-TIME SOCIAL WORKER POSITION FOR AGING AND DISABILITY RESOURCE CENTER AND ADULT PROTECTION SERVICES

WHEREAS, Buffalo County Board has participated in providing Aging and Aging and Disability Resource Center (ADRC) services as part of a regional county partnership; and

WHEREAS, Pepin County has also been a participant since 2010 in this regional ADRC; and

WHEREAS, Pepin and Buffalo Counties plan to continue to partner providing ADRC services and are submitting an application to the State of Wisconsin for an ADRC funding allocation in 2017; and

WHEREAS, ADRC positions have been created and continue to provide services for both Pepin and Buffalo County residents; and

WHEREAS, the ADRC Director position serving all ADRC partner counties was previously a Buffalo County employee and is now a Pepin County employee; and

WHEREAS, this proposed new Social Worker position would provide fully State funded ADRC Information and Assistance services previously provided by a currently vacant Social Worker position in Pepin County. The vacant Pepin County Social Worker position would remain unfilled; and

WHEREAS, the proposed position, while primarily providing Information and Assistance service, would also have the flexibility to provide Adult Protection Services (APS) for Pepin and Buffalo Counties. APS services provided for Pepin County would be fully reimbursed and APS services provided for Buffalo County would be funded by State APS and Elder Abuse allocation; and

NOW, THEREFORE BE IT RESOLVED, that the Buffalo County Board of Supervisors hereby grants authorization to create and fill the full time ADRC/APS Social Worker position.
