RESOLUTION # 18-08-05

A RESOLUTION TO AMEND RESOLUTION #18-07-06 TO SUPPORT REPLACEMENT AND UPGRADE OF UNIFORM ADDRESS SIGNS

WHEREAS, the County passed Resolution #18-07-06 to support the replacement and upgrade of uniform address signs from the CAPX2020 funding to purchase new flag style signs, posts and installation costs and partner with local municipalities to upgrade address signs with a blue flag style design as the County has identified that there are missing, faded or damaged address signs in the County making it challenging for emergency response; and,

WHEREAS, after the adoption of Resolution #18-07-06 the County obtained a quote from Badger State Industries Signage which resulted in a reduction of cost from \$41.30 per sign to \$36.35 per sign; and,

WHEREAS, the County, vendor(s) and participating municipalities will work together to complete this project; and

WHEREAS, the County will upfront the cost from the County CAPX2020 funds for any municipality agreeing to pay 50% of the cost and amend the original agreement date; and,

WHEREAS, the participating municipality shall enter into a written agreement with Buffalo County by no later than September 26, 2018 of their consent to participate and agreeing to pay 50% of the cost by no later than March 1, 2020 to reimburse the County CAPX2020 fund their 50% portion.

NOW, THEREFORE, BE IT RESOLVED, that the Buffalo County Board of Supervisors authorizes the expenditure of CAPX2020 funding to purchase new blue flag style signs, posts and installation costs for any municipality entering into a written agreement by no later than September 26, 2018 and to pay 50% of the costs by no later than March 1, 2020 subject to approval by the Public Service Commission.
