Minutes: Motion made by Claire Waters and seconded by Bruce Kees to accept the minutes of the July 8, 2021, meeting. Motion Passed without opposition.

Public comments regarding posted agenda items: No comments were received.

Review/Discussion Action – Update of County Recycling Agreement with City of Buffalo City, Town of Belvidere, Village of Cochrane and Town of Milton (collectively identified as BBC & M):

Mr. Fuerbringer brought the updated draft of the proposed recycling agreement between the County and the participating municipalities in the County Recycling Program to replace the old agreement that has been in place since the mid-1990's. The agreement would include a provision for local municipalities to sub-contract out their collection responsibilities.

Motion made by Dwight Ruff and seconded by Calvin Lowenhagen to approve the contract's general language and to instruct Mr. Fuerbringer to draft a resolution to approve a contract specifically for BBC&M. Motion carried.
