RESOLUTION # 21-09-02

A RESOLUTION TO CHANGE A POSITION PROVIDING CHILDRENS LONG TERM SERVICES AND PUBLIC HEALTH SERVICES TO ALLOW FOR A PUBLIC HEALTH EDUCATOR OR SOCIAL WORKER OR A FOUR YEAR DEGREE RELATED TO SOCIAL WORK TO FILL THIS POSITION IN ADDITION TO A PUBLIC HEALTH NURSE

WHEREAS, in May of 2021 the Buffalo County Board of Supervisors approved the creation of a single, full-time Public Health Nurse position, effective June 1, 2021 to provide Children's Long Term Services (CLTS-W), reproductive health services, disease investigation and control and other public health services; and

WHEREAS, it remains in the best interests of Buffalo County to increase public health nurse capacity in order to provide protection from public health service interruption in the event of a vacancy and to provide additional needed public health services such as reproductive health services. Recruitment efforts to fill this position have so far been unsuccessful and the need to provide the aforementioned services has become more acute with time; and

WHEREAS, while filling this position with a qualified nurse achieves the additional benefit of providing nursing depth, a Social Worker or Public Health Educator would also be qualified to provide the needed CLTS-W and public health services.

NOW, BE IT RESOLVED that the Buffalo County Board of Supervisors hereby expands the eligibility for this full time position created in May, 2021 so the position can be filled by a Public Health Nurse, Public Health Educator or Social Worker or a four year degree related to Social Work.
