**A Resolution Establishing the 2022 Buffalo County Supervisory Redistricting Boundaries**

Whereas, the Buffalo County Board of Supervisors approved a supervisory redistricting plan for Buffalo County, to become effective for election beginning in 2022, in accordance with Wisconsin State Statute 59.10(3), during August 2021; and,

Whereas, the various Towns, Cities, and Villages within the County reviewed the supervisory redistricting plan, and in accordance with Wisconsin State Statute 5.15, took action as necessary to create or adjust municipal wards to facilitate the administration of elections; and,

Whereas, a public hearing was held on November 9, 2021, for the purpose of soliciting public input for the final supervisory redistricting and ward numbering plan for Buffalo County; and,

Now, Therefore, Be It Resolved that the Buffalo County Board of Supervisors authorizes the adoption of the final County Supervisory Redistricting Plan with the creation of district numbers as follows (map attached for reference):

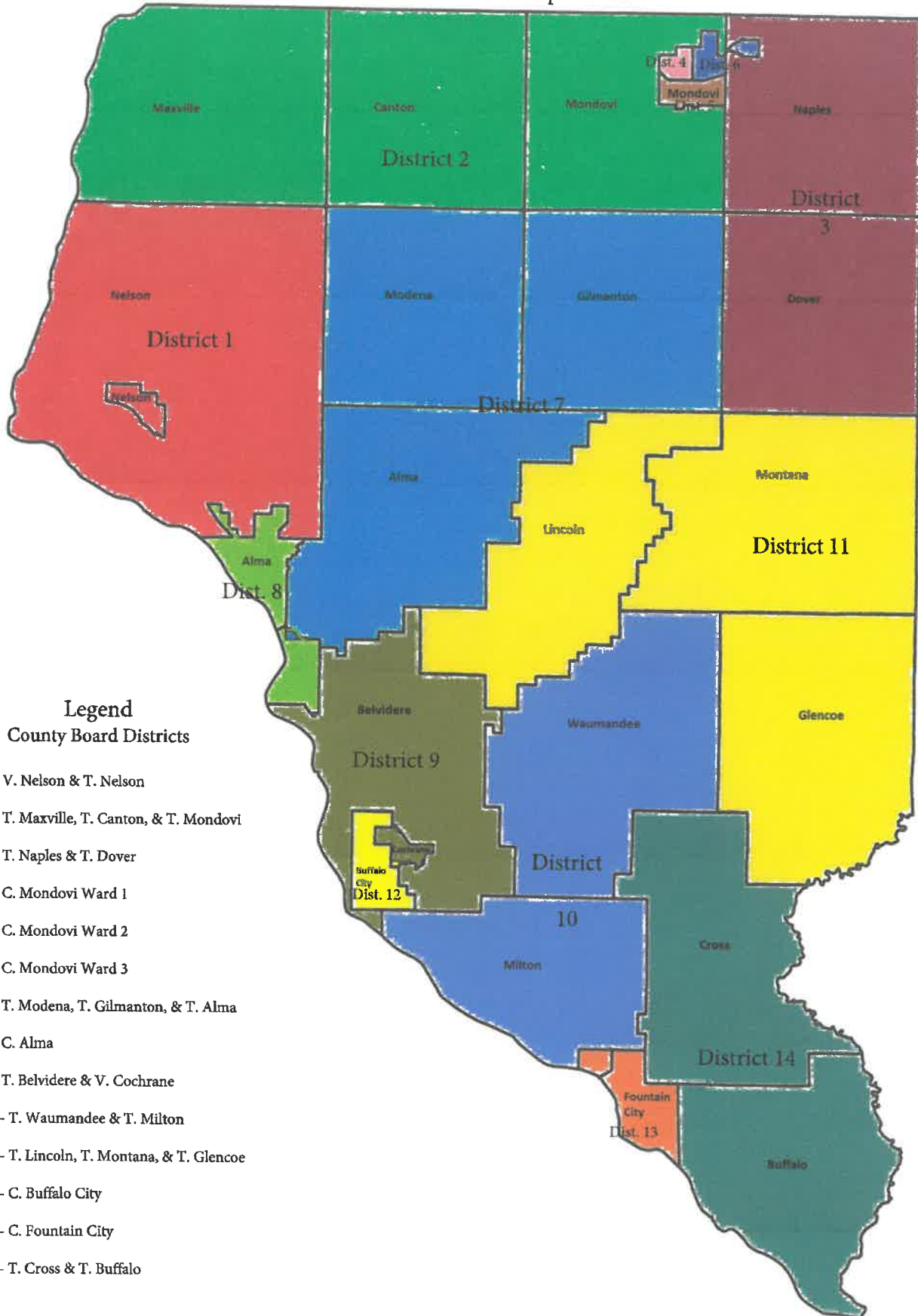
