WHEREAS, 1989 Wisconsin Act 31 and 1989 Wisconsin Act 339 authorized the establishment of the Wisconsin Land Information Program, authorized the development of County Land Information Planning, and allowed the use of local and state funding (from real estate document recording and/or filing fees as collected by the Register of Deeds) for the development of countywide Land Records Modernization planning; and,

WHEREAS, the existing Buffalo County Land Records Modernization Plan of 2019-2021 has been updated, reviewed, and approved by the members of the Buffalo County Land Information Council and the Land Use Committee, and is being sent to the Wisconsin Department of Administration for approval.


