Public Comments Regarding Posted Agenda Items: None.

Review/Discussion/Action regarding A Resolution to Continue Public Health On-Call System Through 2021: Mr. Rynders explained at a statewide zoom conference he attended, the Wisconsin Department of Health Services informed local health departments the promised \$40M funds to cover work done on the pandemic in 2021 were being put on hold. While DHS assures other funds will be provided to replace these funds to cover at least the first half of 2021, details have not been provided except a statement that each local health department would receive \$50,000 via a contract we would receive no sooner than mid-January of 2021. The original allocation information provided designated \$286,000 to Buffalo DHHS Health Unit for 2021 and 2022. There are funds in the Buffalo DHHS budget currently that could be allocated to fully pay for Buffalo Public Health's 3 limited term contact tracers and on-call system through January. He would like this resolution to be approved with a review in January. He will not put levy funds into this as it is a State function. Mr. Hillert made a motion to approve the resolution pending funding and a review in January, seconded by Mr. Weiss. Carried.

Chair Dennis Bork called the meeting to order at 9:00 a.m.

Finance Committee Members Present: Mr. Dennis Bork, Mr. David Danzinger (via TEAMS), Mr. Donald Hillert, Mr. Brad Schmidtknecht, and Mr. Max Weiss.

Others Present for All or Parts of the Meeting: Ms. Sonya Hansen, Ms. Roxann Halverson, Mr. David Schmidt, Mr. David Schams, Ms. Tina Anibas (via TEAMS), and Ms. Lisa Schuh (via TEAMS).

Public Comments Regarding Posted Agenda Items: None.

Review/Discussion/Action regarding Previous Meeting Minutes: Mr. Weiss made a motion to approve the minutes by roll call vote, seconded by Mr. Hillert. All in favor. Carried.

Review/Discussion/Action regarding A Resolution to Purchase 2021 Equipment Investments for Buffalo County Highway Department: This resolution would allow the Highway Department to purchase equipment as long as it stays within the budgeted amount. Mr. Hillert made a motion to approve the resolution by roll call vote, seconded by Mr. Weiss. All in favor. Carried.

Review/Discussion/Action regarding the Solid Waste Management Code: Ms. Hansen discussed the Solid Waste Code and explained there are some items that need to be updated. The code refers to a Solid Waste Director, Solid Waste Committee, and has the permits issued by the County Clerk. The Finance Committee would like the Recycling Committee to review this and have it approved by the Highway Committee.

Review/Discussion/Action regarding a Financial Report on Phase I of the Great River State Trail – Winona Connector Trail: Mr. Schmidt and Ms. Hansen explained the expenses for the trail came in at \$3.2 million, fundraising efforts have brought in \$764,000, there was a DNR grant for \$282,000, and he is currently working on a \$400,000 Land and Water Conservation grant. Other grants have paid for some of the expenses but there is approximately \$391,000 left to be reimbursed (after \$150,000 of CAPX funds are applied). The Flyway Trail does have some funds available to help with costs but wants to use their funds towards grants that require matching funds for Phase 2 of the trail. Phase 2 will not begin until all funding and reimbursement for Phase 1 has been completed. Mr. Schmidt also wants Phase 2 to not begin until funding is secure for that part of the trail. Phase 2 is estimated at \$2 million for 2 miles of trails. Mr. Danzinger made a motion to approve using \$150,000 of CAPX funds and

charge 1% interest to the Flyway Trail Group to pay off the remaining balance by June 30, 2021, seconded by Mr. Weiss. A roll call vote was taken. All in favor. Carried.

Mr. Schams from the Flyway Trail Group also explained they are willing to enter into a maintenance agreement with Buffalo County for the trail. This will be brought forward at another time.

Review/Discussion/Action regarding Government Crime Renewal Insurance

Coverage: Ms. Hansen explained we currently have coverage for employee theft at \$100,000. AEGIS is recommending to expand that coverage. The Committee discussed the three coverage options. Mr. Hillert made a motion to move forward with option 3 for coverage by roll call vote, seconded by Mr. Schmidtkecht. All in favor. Carried.

Review/Discussion/Action regarding 2021 Proposed Finance Committee

Calendar: The calendar has the meetings set for Thursday mornings. Mr. Hillert made a motion to adopt the calendar by roll call vote, seconded by Mr. Schmidtkecht. Carried.

Review/Discussion/Action regarding Monthly Vendor Invoices, Vouchers, Employee Payroll, and Funds Investment Report:

Invoices were discussed. Mr. Hillert made a motion to approve invoices, vouchers, and employee payroll by roll call vote, seconded by Mr. Schmidtkecht. All in favor. Carried.

Chairperson Report: None.

Administrative Coordinator Report: Ms. Hansen reported that one of the CAPX cd's will be coming due. This will not be renewed as there are expenses that need to be paid out of it. Mr. Rynders has received an email confirming his department will receive \$112,000 of CARES Act funds towards the three limited term positions and on-call wages. He will bring this forward in January for review. The short Finance meeting before County Board will not be paid a per diem, but the other joint committee meeting will. Interviews were held for the Administrative Assistant position.

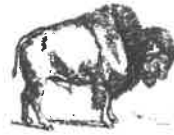

A RESOLUTION IN SUPPORT OF INCREASED COUNTY CHILD SUPPORT FUNDING

WHEREAS: Buffalo County administers the Child Support Enforcement Program on behalf of the state, providing services to over 750 Buffalo and Pepin County cases including paternity establishment, obtaining child support and health insurance orders for children, and enforcing and modifying those orders; and

WHEREAS: Our children's well-being, economic security and success in life are enhanced by parents who provide financial and emotional support; and

WHEREAS: County child support agencies collected \$935 Million in child support during 2019 and established 98,405 health insurance orders for Wisconsin children; and

WHEREAS: Buffalo County's Child Support Agency provides services to children as well as custodial and non-custodial parents that reduce childhood poverty rates, establish parental rights and promote the involvement of both parents in the lives of their children; and

WHEREAS: The economic security and social service programs provided by Buffalo County Child Support Agency are needed by Wisconsin children and families now more than ever due to the economic downturn caused by COVID-19; and

WHEREAS: State funding for county child support services has failed to keep up with county agency costs, which have steadily increased due to growing caseloads, inflation and new federal regulations; and

WHEREAS: Wisconsin's Child Support Enforcement Program has fallen from 2nd in the nation for collecting current support to 5th; and

WHEREAS: Wisconsin's decreased performance has led to the state losing out on an estimated \$70,000 in potential federal incentive payments between Calendar Year 2019 and 2020; and

WHEREAS: An abrupt federal interpretation change in June 2019 eliminated \$4.2 million in federal birth cost recovery matching funds for Wisconsin; and

WHEREAS: Wisconsin's strong performance in child support is at risk without additional state funding. Further drops in performance would result in additional reductions to federal funding for Wisconsin; and

WHEREAS: Decreased federal funding results in less funding for Buffalo and Pepin County's child support agency. This could lead to reductions in child support enforcement staff and services and reduced child support collections; and

WHEREAS: New state investments in child support are amplified by a generous federal match. Every \$1 of state GPR invested in the Child Support Program generates roughly \$2 in federal matching funds; and

WHEREAS: Wisconsin's Child Support Enforcement Program is incredibly cost-effective, collecting an average of \$6.20 in support for every dollar invested in the program.

NOW, THEREFORE, BE IT RESOLVED that the Buffalo County Board of Supervisors respectfully requests that state funding for county child support agencies be increased by \$4 million GPR in each fiscal year of the 2021-23 Wisconsin state budget, which will generate approximately \$7.7 million in additional federal funding each year. This investment will ensure that Wisconsin counties can continue to effectively provide economic support to our children.

IT IS FURTHER RESOLVED that a copy of this resolution be forwarded by the County Clerk to the Governor of the State of Wisconsin, State Senators and State Representatives representing Buffalo County, the Secretary of the Wisconsin Department of Administration, and the Wisconsin Counties Association for consideration.

Poll Book Issues:

1. Absentee Notations not in red. Please make all absentee notations in red (example: 12A). This helps us record the voter correctly and makes the election reconciliation process more efficient.
2. The voter moved or changed their name but were not made to re-register. If voter has physically moved or changed their name, they need to re-register and have their information and signature captured on the Supplemental Sheets. If the voter does not re-register their information will not change in the poll book.
3. The voter moved or changed their name and re-registered but still signed by their pre-printed name not on the supplemental list. If the voter moved or changed their name, the signature and other information need to be captured on the Supplemental sheets. DO NOT allow them to sign by their pre-printed information and do not include it in both places.
4. The voter is not in poll book, so the Poll Worker entered the voter name on supplemental list and an old registration form is sent to us. DO NOT DO THIS! There may be a few reasons the voter is not showing up on the poll book. They may have not voted in 4 years and were removed for inactivity. They may have registered in another municipality/state and were removed from the poll book. The old registration form was incomplete, and the missing information was never provided, therefore cannot be added to the poll book. Have any voter not on the poll book register and provide the necessary information they need. We cannot allow a voter to vote without being properly registered. This could be considered voter fraud.

Voter Registration Form Issues:

1. The voter did not sign the registration form. The voter signature is essential as it is the voter saying they are legally able to vote in the US and in your municipality. If there is no signature the Municipal Clerk will need to obtain the signature. The voter will be made inactive until the signature is obtained, and proof is sent to us. If they are still inactive for the next election the voter will need to complete a new voter registration form.
2. The Poll Worker or Clerk did not sign the registration form. The Municipal Clerk will be responsible for obtaining the official signature.
3. There was no WI driver license number entered on the registration form. The Municipal Clerk will be responsible for obtaining the driver license number and providing proof to the County Clerk's Office. The Voter will be made inactive until this is obtained. If they are still inactive for the next election they will need to re-register.

4. The voter was allowed to use expired WI driver license. The Voter will be made inactive and will be required to re-register for the next election and provide proper proof of residence.
5. The voter was allowed to use an out of state driver license. Any out of state ID is not acceptable. The Voter will be made inactive and will have to re-register at the next election and provide acceptable proof of residence.
6. The voter was allowed to use a doctor bill, health insurance bill, or car insurance bill. Check the list of acceptable forms of proof of residence. If a voter is allowed to use an invalid proof of residence, they will be made inactive and will have to re-register with proper proof of residence to be able to vote. Do not choose Care Facility as a proof of residence for a doctor bill. Care Facility is only for those voters who live in a nursing home or assisted living situation and have proof of residence from that care facility.
7. The Poll Worker did not circle type of proof of residence. The form will be returned to the Municipal Clerk for proper proof of residence and the voter will be made inactive. If the voter is still inactive at the next election they will be made to re-register.
8. The Poll Worker did not write down the entity that issued the proof of residence. Example if the voter used a utility bill...who is the utility company (Riverland, Excel??)
9. No date of birth was entered on the registration form. The Municipal Clerk will be responsible for obtaining this information. The voter will be made inactive and will need to re-register if the missing information is not provided to the Clerk's Office prior to the next election.
10. The registration form contained no address for the voter. The Municipal Clerk will be responsible for obtaining this information. The voter will be made inactive and will need to re-register if the missing information is not provided to the Clerk's Office prior to the next election.
11. The voter used an online form (full form printed and handed in) and the voter did not sign or provide proof of residence. If the voter is using MyVote to register you will get an email with the information in a ½ sheet spreadsheet format. This shows that the system checked for proof of residence and voter does not have anything to sign or need to show proof of residence. If it is a full sheet of paper that has the state seal and says that it was printed online or printed and mailed, then voter needs to sign and provide proof of residence. In this case the voter only used the system to print out the form they did not submit it for the system to check the information.
12. The Poll Worker allowed a voter to use a marriage license to say they changed their name. A marriage license is not acceptable form of proof of ID. The voter would need to vote with their maiden name until such time as they get a valid WI ID to show their name change.

13. The Poll Worker has circled two items as proof of residence on the registration form. **There should only be one thing circled as they only need to show one proof of residence. If they used a driver license only circle that.**

Inspector's Statement EL-104 Issues:

1. Forms are not properly completed. Examples:
 - A. Tamper Evident Seal and memory device serial number in Section #2 is not entered.
 - B. The Chief Inspector does not initial that they checked the tamper evident seal number on the machine is the same as written on this form. The Chief Inspector initialed the form but there is no seal number on the form (so how could they verify anything). The Municipal Clerk initialed there when it needs to be the Chief Inspector checking the Municipal Clerk's work.
 - C. Number of Voters , number of Election Day Registrations, number of absentee voters on poll list (this means returned and counted ones not those not returned or rejected), number of provisional ballots, number of hand count/optical scan/touchscreen ballots issued are not entered in Section 4.
 - D. Election workers or Chief Inspectors did not sign the form. You need to have a Chief Inspector for the entire day not just part of the day.
 - E. There is nothing written on the second page. You know something happened during the day. The machine was not set to the correct time? You ran out of ballots and had to call for more? You had someone come in and try to use their marriage license to prove they changed their name? This should never be blank.

Absentee Ballot Report Issues:

1. We do not get the absentee ballot report within 48 hours of the ballot being issued or receiving the ballot back. **By State law we only have so many hours to enter requesting and returning information into WisVote. This is so that voters can go into MyVote and make sure you sent it out or received it back to be counted. We received calls on this in November. More and more voters are using MyVote to check their ballot status.**
2. The number of absentee ballots issued/returned does not match the number of absentee voters on the poll list. **Having less absentee voters on the poll list than on your absentee report is fine as long as the extras on your report are ones that have not been returned before election day.**

If there are more absentee voters on the poll list than on your report there are issues. It means your report is not complete and we do not have the correct data to enter into WisVote.

3. Different formats of the report have caused some issues. Although we do not want to make this difficult for anyone, if the report is sent to us as a picture we cannot print those pictures that are text/emailed to us. This makes entering the information and checking it off to make sure it is correct very difficult. Please use an Excel spreadsheet to send us your absentee information. This format is easy for both our office and you to use. Easy to update and highlight new information. A Word document will be acceptable if you have a way to highlight only the new information for us and change the old information back to black to show it has already been submitted to us.
4. Numbering the voters on the absentee report would be very helpful. This will help us make sure that the number of absentee ballot you sent is the number we have recorded in WisVote.
5. Make font big enough to read. Small font and too much information makes it difficult to enter the information we need in WisVote.
6. Highlighting new information on the absentee report. Make anything new for that day a different color other than black and then turn all the past information to black so we know what is new. Do not use a different color for each day as this makes it difficult to know what is new.
7. Keep the information on your report as basic as possible. This chart shows what we need to enter into WisVote.

A RESOLUTION TO DESIGNATE 2021 FUNDING FOR BUFFALO COUNTY BROADBAND EXPANSION

WHEREAS, Buffalo County adopted Ordinance No. 17-09-01 and Resolution No. 17-12-06 to encourage the development of broadband access in Buffalo County; and,

WHEREAS, each year the availability of project funding is to be determined by the Buffalo County Board of Supervisors; and,

WHEREAS, the County Board of Supervisors adopted Resolution #20-05-04 which allocated a total of \$200,000.00 of CAPX 2020 funding for the calendar year 2020; and

WHEREAS, one broadband project was approved in 2020 in the total cost of \$30,525.55 of which the County contributed \$6,000.00 from broadband funding; and,

WHEREAS, the Economic Development Committee recommends that \$200,000.00 be designated for the calendar year 2021 for the purpose of improving the quality and availability of broadband communications.

NOW, THEREFORE BE IT RESOLVED, that the Buffalo County Board of Supervisors hereby approves CAPX2020 funding up to \$200,000.00 to be designated for the purpose of improving the quality and availability of broadband communications in underserved and unserved areas of Buffalo County under the broadband award policy subject to approval by the Public Service Commission for the calendar year 2021.

NOW, THEREFORE BE IT FURTHER RESOLVED, that the 2021 budget be amended to include this designation and fund expenditure.
